Chanticleer Holdings, Inc., a Delaware corporation, pursuant to negotiations with holders of certain warrants, reduced the exercise price of an aggregate of 382,928 outstanding warrants to \$0.50 as an inducement for exercise. The transactions were not subject to a definitive agreement and the settlement of the shares occurred between March 19, 2020 and March 25, 2020.

The transactions discussed in this paragraph are exempt from registration pursuant to Section 4(a)(2) of the Securities Act, and corresponding provisions of state securities laws or, alternatively, Section 3(a)(9) of the Securities Act and corresponding provisions of state securities laws, on the basis that (i) offers were made to a limited number of existing warrant holders, (ii) each offer was made through direct communication with the offerees by Chanticleer, (iii) the sophistication of the offerees and financial ability to bear risks (iv) the extensive disclosure provided by Chanticleer to the offerees, and (v) no general solicitation and no commission or remuneration was paid for solicitation.
